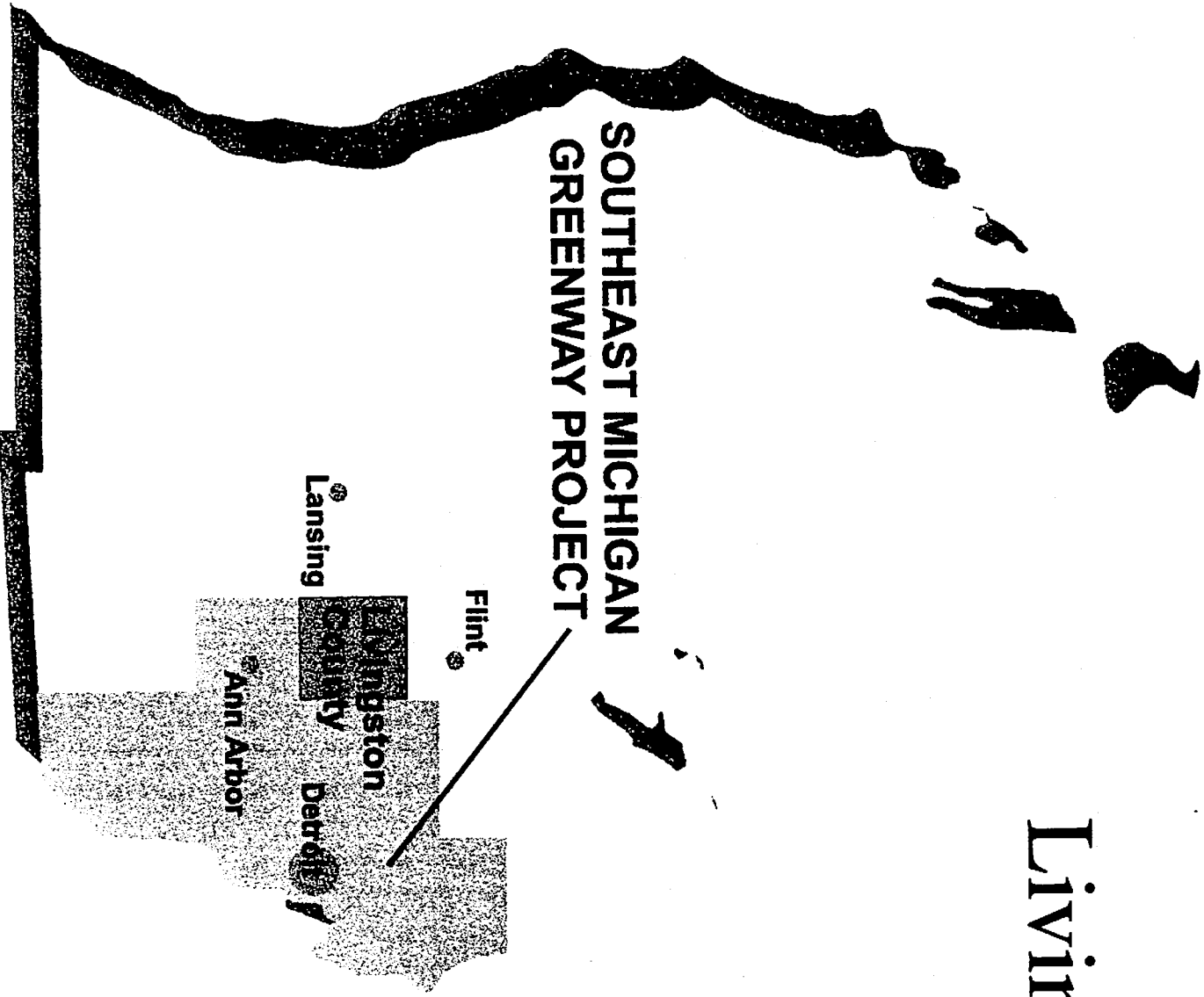

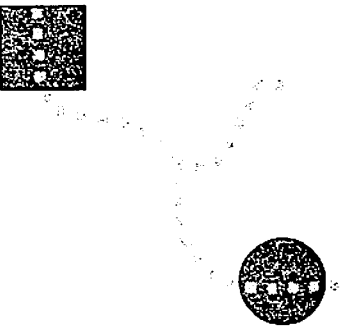
# What is a Greenway?

## Greenway

1. A linear open space established along either a natural corridor, such as a riverfront, stream valley, or ridgeline, or overland along a railroad right-of-way converted to recreational use, a canal, a scenic road, or other route.
2. Any natural or landscaped course for pedestrian or bicycle passage.
3. An open-space connector linking parks, nature reserves, cultural features, or historic sites with each other and with populated areas
4. Locally, certain strip or linear parks designated as a parkway or greenbelt. [American neologism: green+way; origin obscure.]

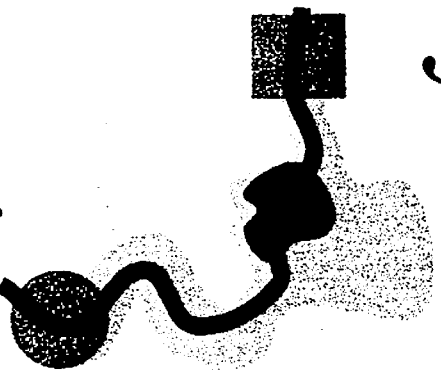

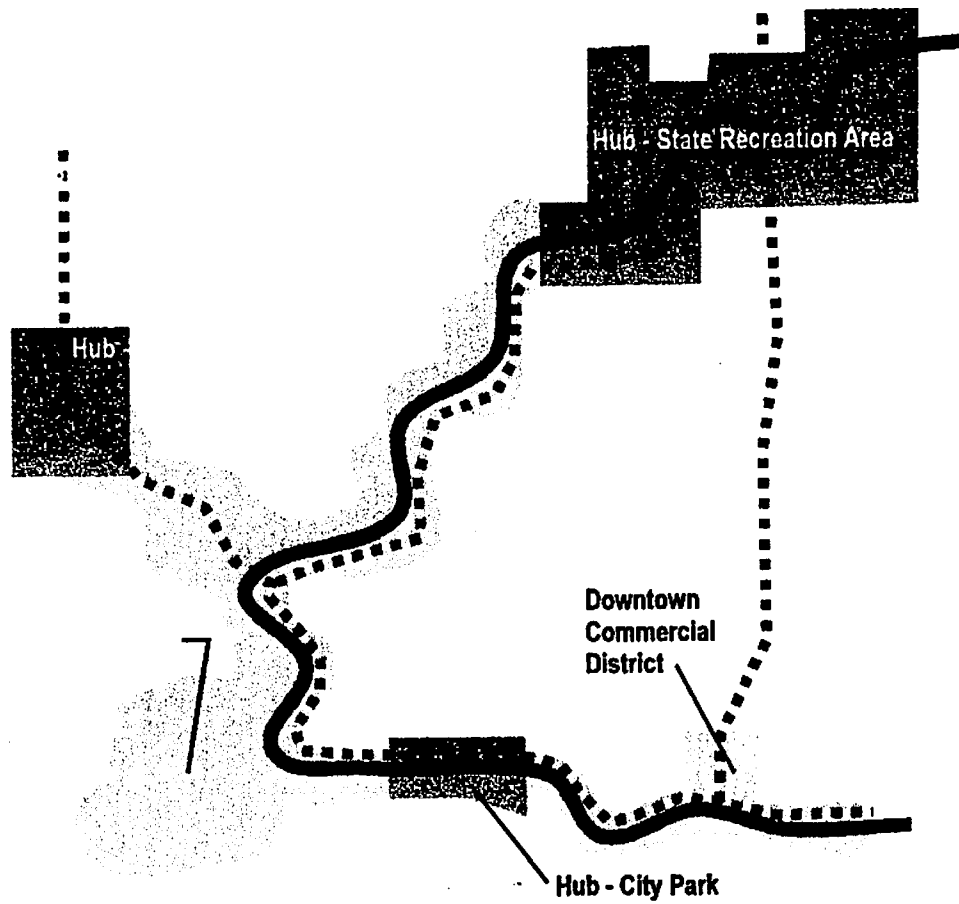

- At what point should they become involved?

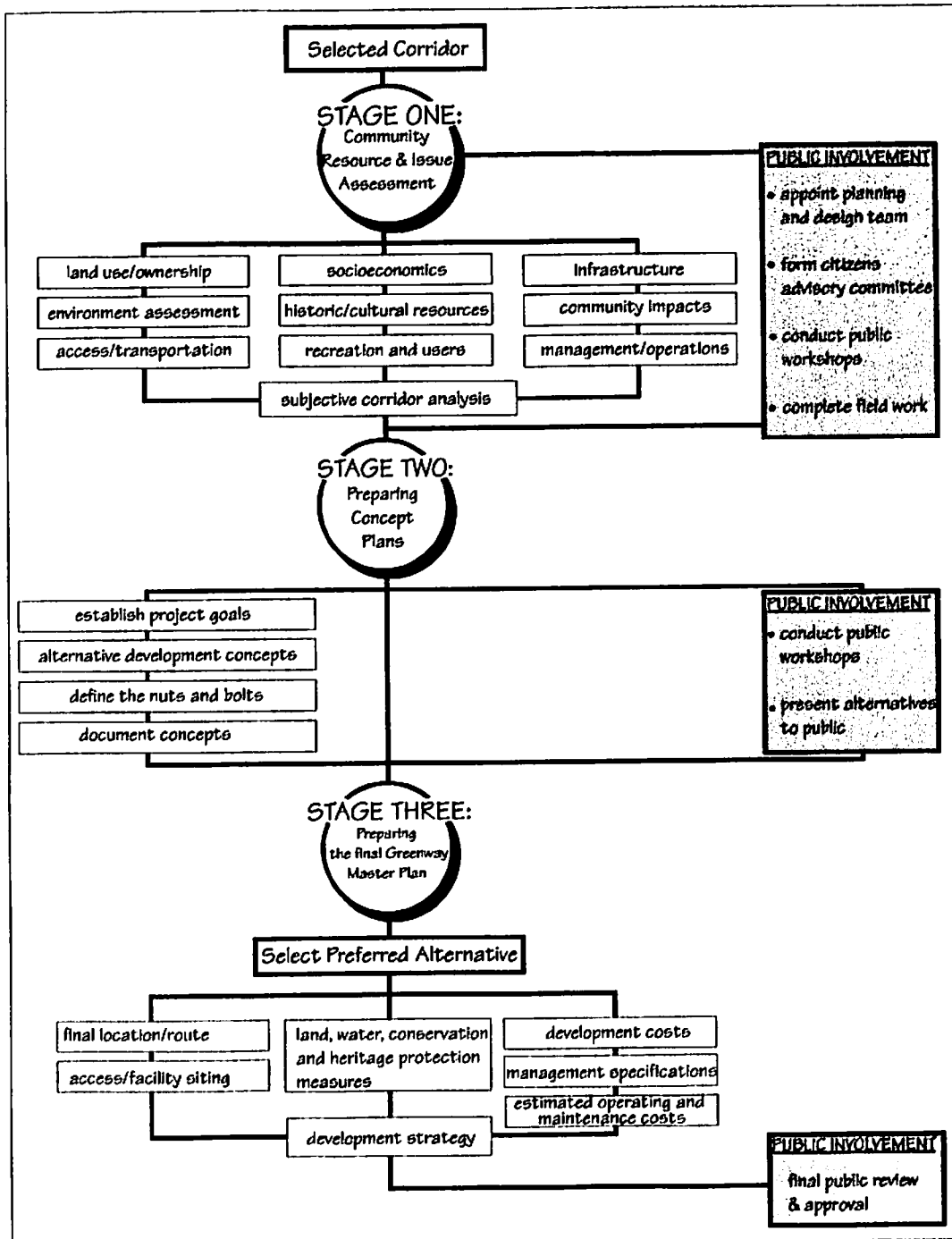
A greenway steering committee should represent a broad range of community stake holders, including the following:

- Township and City Officials (Board/Council members or Planning Commission)
- County, State, and Federal Departments and Agencies (Planning Department, Road Commission, County Commissioners, MDOT, MDNR, etc.)
- Environmental Experts and Agencies
- Land Conservancies
- Developers/Home Builders/Realtors
- Farmers
- Recreation Interests
- Local Business Owners and Chamber of Commerce
- Landscape Architects/Engineers
- Utility Companies
- Potential opposition to greenways plan .

# Responsibilities of Greenway Steering Committee

- Review the recommendations of the planning team on such issues as routing, location, and design details.
- Serve as liaisons to local governments, groups, and neighborhoods.
- Define funding, implementation, and management strategies.
- Discuss land-acquisition strategies that might involve land owners, business, government agencies, and land trusts.
- Formulate marketing and promotion ideas for the greenway.
- Promote land stewardship activities to preserve sensitive habitats, unique landscapes, and historic resources.

# Greenway Planning Process



As the project evolves, the focus of the steering committee changes from planning to funding and implementation.

must follow.**

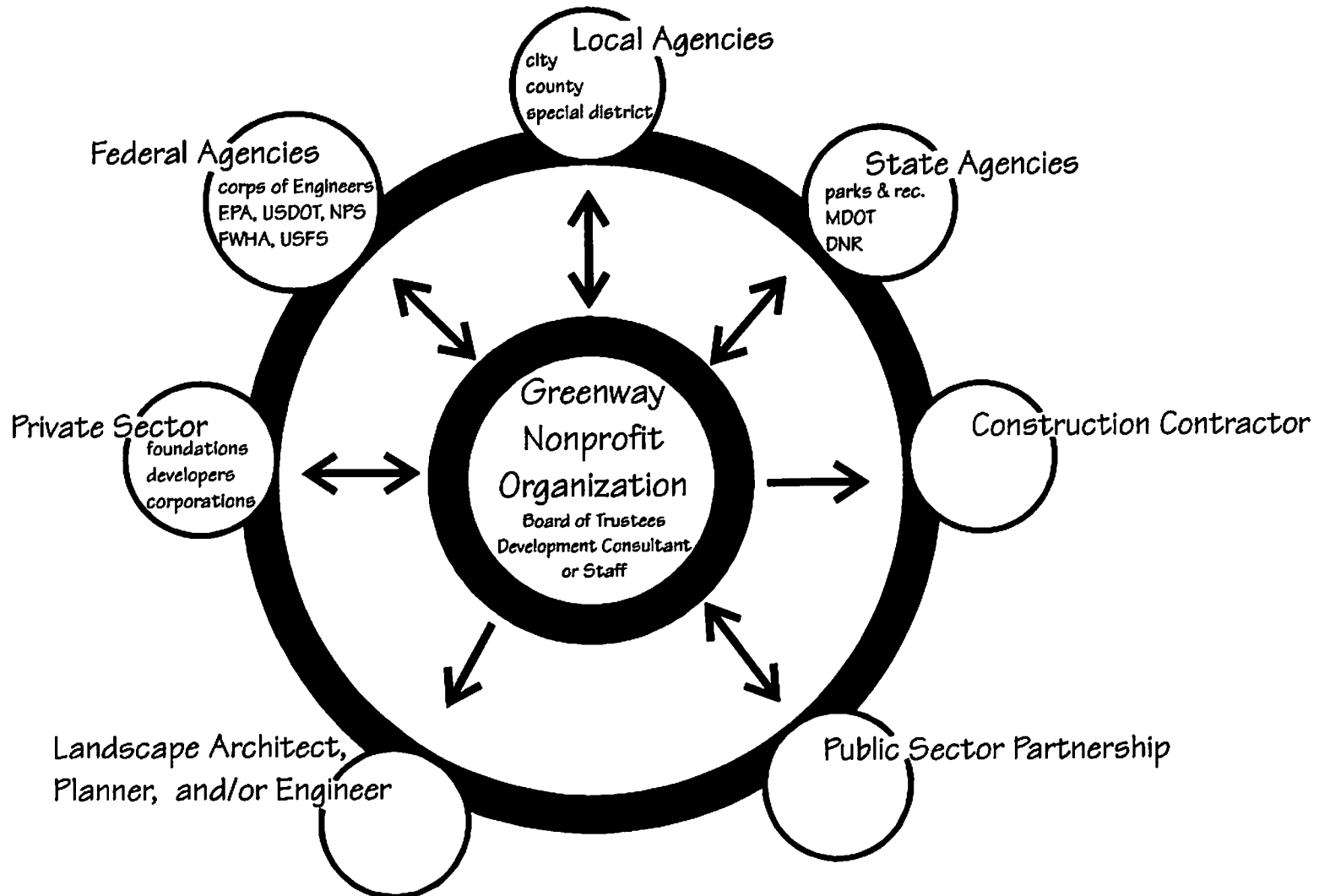
